**SATURDAY, MAY 23, 2020 – Travel Day**

5:00 AM **GROUP** will meet at **DETROIT METROPOLITAN AIRPORT – MCNAMARA TERMINAL (DELTA)**. Meet your full time **TOUR DIRECTOR(S)**, who will travel with you from beginning of trip until you return.

The Group Ticketing area is the first entrance of the McNamara Terminal (please do not go to the North Terminal).
